ANIMAL SURRENDER CONTRACT

Faithful Friends Animal Sanctuary (FFAS) desires to be a service source where potential pet adopters can be matched with animals in need of new homes. We recognize that unfortunate circumstances can develop in responsible pet owners' lives that cause them to consider parting with a beloved pet. **Please note that FFAS requires a non-refundable surrender fee of \$50.** This fee is used to help defray expenses (veterinary care, food, shelter, etc.) related to animal care.

In an effort to make this parting and subsequent search for a new home less traumatic, please complete the Animal Surrender Questionnaire to aid in the search. It will also be helpful if you provide FFAS with your pet's veterinary records.
